Evidence based equality analysis

The Local Offer website was commissioned following the introduction of the Care Act 2014. The website aims to give residents of Cheshire West and Chester a directory of services along with advice and information. The website is still being populated with the relevant information and services available within the borough.

A paper directory has also been published and has been signed off for print. This will ensure that Cheshire West and Chester citizens have access to information, advice and services if, for example, they do not have access to the internet. The directory is available in accessible formats upon request.

The Local Offer also offers users the option to carry out a self-assessment, which following completion of 30 questions (with the majority being yes/no answers) will signpost them to local services and advice and guidance articles. Following the completion of the self-assessment, users can then refer to the Gateway team if they feel further input is needed from social services (e.g. social worker, OT etc).
