UPDATE FROM HEALTH PARTNERS TO INCLUDE "WAITING WELL" SERVICE

Presented by Sean Donnelly, Learning Disability and Autism Project Manager for Integrated Care Board, Cheshire and Merseyside, and Tom Egerton-Parry, Operational Manager for Cheshire & Wirral Partnership's Adult Autism and Adult ADHD Services

Sean gave a presentation which highlighted some of the services commissioned by the Integrated Care Board, all of these services are on the Live Well site Home | Live Well Cheshire West.

The presentation will be shared with members in due course but during the conversation Tom shared that Cheshire & Wirral Partnership Autism Outreach Workers were being recruited and will become a front door service who will help signpost those already diagnosed as well as those without a diagnosis.

PRESENTATION ON PINS (POSITIVE INCLUSION NEURODIVERSITY IN SCHOOLS

Presented by Gill Tyler, Designated Clinical Officer for Special Education Needs and Disability, Cheshire and Merseyside Integrated Care Board
