Title of policy / procedure / function / project / decision:

Change to kerbside waste and recycling collection times

Evidence based equality analysis

In response to the increase in extreme weather events residents will be asked to present their waste and recycling containers from 6am

To date, recycling and waste collections in the borough have taken place with advice for residents to present containers for emptying by 7am on their scheduled day of collection. Collection services by Cheshire West Recycling begin across the borough from this time. A change is now being made to this start time and residents will be asked to present their containers for emptying one hour earlier on their scheduled collection day.

What is happening

A permanent change to the collection start time is being made to allow Cheshire West Recycling to carry out a more efficient service for both staff and residents. Residents are currently advised to present containers on their scheduled day for 7am to ensure they are emptied. However, residents will be asked to present their waste and recycling containers one hour earlier at 6am on their collection day to reduce the risk of a missed collection.

Outcomes

This change will allow for greater flexibility during unforeseen circumstances or events. For example, the change supports any operational challenges, such as hot weather conditions where high temperatures during the day can be difficult for collection staff. The challenges of a high UV index for waste collections crews are sunburn and long-term skin damage. Persistent high temperatures can make working in PPE uncomfortable and heightens the risk of dehydration and heat stroke. Allowing an earlier start time during a hot weather spell will allow collections to take place during cooler working hours and minimise any negative effects hot weather might have on our service to residents and the well-being of CWR employees.

Other authorities across the county already have a start time of 6am so this change is nothing unusual for the kerbside collection service. The crews will still start at their usual time, unless the Council and CWR (Cheshire West Recycling) collectively agree to an earlier collection due to a weather warning or event where an earlier start means more residents can have their bins collected as scheduled before a service may have to be suspended for the day due to hot weather, storm warnings, snowfall and special events such as royal visits or sporting events affecting specific areas.

It is important that residents get used to the earlier start times as it will not be possible to communicate earlier start times at the time they are needed in an effective way.

Most residents put out their waste the night before and will be unaffected by the changes, although this practice is only tolerated if the waste is fully contained and the containers are presented in a way that they are not causing an obstruction.

It is recommended that the new start time be promoted ahead of the summer season, so people become accustomed to the changes. A full comms plans will be developed ahead of any changes. Information provided on the web site and self-service forms will be updated and will reflect the earlier collection time with guidance for residents to present waste and recycling containers by 6am. Social media messages and e-Newsletters will also be used as a channel to share this change with residents across the borough.

The Met Office advises:

- Hotter and drier summers are likely to become more common.
- The ten warmest years on record have occurred since 2002.
- We are experiencing higher maximum temperatures and longer warm spells in recent years.
- The likelihood of extremely hot days in the UK will continue to increase.

The HSE recommends the following mitigations:

- Reschedule work to cooler times of the day (please note this is the only advice currently not being adhered to by CWR)
- Provide more frequent rest breaks and introduce shading to rest areas.
- Provide free access to cool drinking water.
- Introduce shading in areas where people are working.
- Encourage workers to remove personal protective equipment when resting to help encourage heat loss.

• Make sure workers can recognise the early symptoms of heat stress.
