Chester Christmas Parades  
(27<sup>th</sup> November, 04<sup>th</sup> December and 11<sup>th</sup> December 2025)

(Temporary Traffic Regulation) Notice 2025

Notice is hereby given pursuant to the provisions of Section 16A of the Road Traffic Regulation Act 1984 that the Cheshire West and Chester Borough Council intends to make a Notice to the effect of which will be to temporarily prohibit traffic on following roads in the Chester City Ward to enable the Chester Christmas Parades (Lanterns Parade, Winter Watch Parade and Winter Watch & Saturnalia Parade) to be carried out by the organiser.

The Notice will come into force on the 27<sup>th</sup> November, 04<sup>th</sup> December and 11<sup>th</sup> December 2025, and will close the following roads as detailed below.

The following lengths of road will be closed from 10:30 until 20:00 under the provisions of the ATTRO Order.

- Northgate Street (from Princess Street to Eastgate Street).
- St Werburgh Street (from Northgate Street to Eastgate Street).
- Eastgate Street (from Northgate Street to Foregate Street).
- Foregate Street (From the Eastgate Street to St John Street).
- St John Street (to a point 33 metres south of Foregate Street).
- Bridge Street (to a point 140 metres north of Grosvenor Street and Pepper Street to Watergate Street).
- Watergate Street (from Bridge Street to St Martin's Way and Nicholas Street).

The following lengths of road will be closed from 17:30 until 20:30.

- Hamilton Place (from Crook Street to Goss Street).

The following lengths of road will be closed from 18:30 until 20:00.

- Northgate Street (from Hunter Street to Princess Street).
- Princess Street (from Northgate Street to a point 8 metres west of Northgate Street).

The Order will suspend parking, loading and unloading on the following roads between 16:30 and 20:00 on the 27<sup>th</sup> November, 04<sup>th</sup> December and 11<sup>th</sup> December 2025.

- Hamilton Place (from Crook Street to Goss Street).
- Northgate Street (from Hunter Street to Princess Street).
- Princess Street (from Northgate Street to a point 8m west of Northgate Street).

Pedestrian access to premises situated on or adjacent to the roads will be maintained at all times.

Nothing in the Order shall prevent driving upon the said lengths of road of any vehicle which is being used in an emergency for fire brigade, ambulance or police purposes, and agreed vehicles linked to the safety and logistics for the event delivery.

The promoter of the event is Cheshire West and Chester Council.
