Impact on community partnership:

The amendment affects Winsford community partnership.

There are five remaining pharmacies in Winsford community partnership open on a Saturday.

Impact on community partnership:

The pharmacy is in Ellesmere Port community partnership but as it is moving to a new premises, the number of pharmacies will remain the same. The opening hours will also remain the same.

The new location is a 15 minute walk from the existing premises, or a 2 minute drive or average 10 minutes on public transport.

It is the opinion of Helen Bromley, Director of Public Health that the relocation of this pharmacy does not create a gap in pharmaceutical services provision that could be met by a routine application:

- to meet a current or future need for pharmaceutical services
- to secure improvements, or better access, to pharmaceutical services

Impact on community partnership:

The amendment affects Ellesmere Port community partnership where the number of community pharmacies will reduce to 11. The number of pharmacies in the borough will reduce to 67.

There is a reduction in provision before 9am and after 17:30pm. This reduces the number of pharmacies open later in Ellesmere Port to three. The new location is a 3 minute walk or 1 minute drive from the closing location.

It is the opinion of Helen Bromley, Director of Public Health that the removal of this pharmacy from the pharmaceutical list does not create a gap in pharmaceutical services provision that could be met by a routine application:

- to meet a current or future need for pharmaceutical services
- to secure improvements, or better access, to pharmaceutical services
