

# Climate Local: Cheshire West and Chester Council

## Our progress on 1 January 2014

Since signing up to Climate Local on 22 October 2012, we have made the following progress towards achieving the commitments and actions we pledged on 4 December 2013.

#### Details of Governance arrangements:

The actions, measure and targets that form the basis for our Climate Local Commitments have been developed through the Borough's Sustainability Commission of Inquiry. The Final Report and Action Plan "A Sustainable and Resilient Future for West Cheshire" was approved in December 2013. The Council's Corporate Scrutiny Committee has now been tasked to take on the overall responsibility for monitoring the delivery of the plan. This will involve reporting progress to Corporate Scrutiny Committee every quarter on all the 41 Actions. Where targets are not being met Corporate Scrutiny will be able to ask for and identify blockages or hurdles to their delivery. Where the Council can act to address these and a decision is required, recommendations will be made to Executive. Where Actions are identified as having been met, Corporate Scrutiny will be able to undertake a check and if satisfied provide an endorsement.
