# Conversion Grant



This grant is for the conversion of long term empty property or obsolete commercial premises to provide new units of private rented residential accommodation.

## Who can apply for a Conversion Grant?

You may be eligible for a Conversion Grant if:


- The dwelling or premises has been vacant for at least 12 months.
- Planning permission has been granted for the conversion.
- The properties are of a type and size identified by the Council as required to meet a housing shortage within the borough, and in areas where there is an identified need
- You have an owner's interest in the property

## How much grant can I apply for?

You may apply for a grant covering 50% of the cost of the eligible works up to a maximum of £10,000 per self-contained unit of accommodation, with a maximum of £50,000 per overall scheme. Council officers will also work out what is a reasonable cost for the work to be carried out including VAT and all eligible fees. The grant is non repayable unless a condition is breached.

## How will my property be assessed?

You will be asked to submit architects plans, planning permission, building regulation approval and a schedule of the conversion / repair works, together with two quotes for the costs of the works. An officer from the Private Sector Housing Team will need to inspect the property in its unimproved condition. We will then establish the eligible costs for the works.



## What conditions apply if my application is successful?

There are a number of conditions that apply in respect of the award of a Conversion Grant. These include:

- The owner / landlord must become a member of the Cheshire Landlord Accreditation Scheme on completion of the works.
- The units must be let at an affordable rent (Local Housing Allowance rate) or below and allow the Council to nominate tenants for 5 years.
- No further assistance is available for the property for 15 years from the completion date for that property.
- The property must meet the Government's decent homes standard and be occupied before payment of the grant.
- Work must be completed and property occupied within 12 months of the grant being approved.

**Please Note:** Owners must submit their application and have received written approval before starting the works and that grants and loans offered by the Council are subject to available funding.

## How do I apply for an Conversion Grant?
