# Empty Homes Grant

To help owners and private landlords bring empty homes back into use by contributing towards the cost of essential repairs such as upgrading electrical wiring, damp proof work, provision of heating or replacing gutters etc.

The grant can be used to pay for a contractor to carry out repairs or towards the cost of materials if you are doing the work yourself.

## Who can apply for an Empty Home Grant?

Owner-occupiers and private landlords can apply for this grant subject to the following conditions:


- The applicant must have an owner's interest in the property
- Must be a residential property that has been empty for at least 18 months and must be non-decent.
- For owner-occupiers the property must be in council tax bands A to D

## How much grant can I apply for?

Home owners and private landlords can apply for a grant of 50% of the cost of eligible works up to a maximum of £2,000, subject to satisfactory receipts. In addition private landlords who guarantee to let at an affordable rent and allow the Council to nominate tenants for 5 years can apply for a grant of 50% of the cost of eligible works up to a maximum of £10,000.

## How does it work?

The grant is awarded for structural / repair works and / or labour. Fees, decoration and floor coverings are not eligible. Owners and private landlords must submit an application and have received approval in writing before starting the works. Applicants then submit receipts to the Council to demonstrate the amount they have spent on repairs. An officer from the Private Sector Housing Team will need to inspect the property to confirm the works have been completed.



## What conditions apply if my application is successful?

There are a number of conditions that apply in respect of the award of an Empty Home grant. These include:

- The property must meet the Government's decent homes standard and be occupied before payment of the grant can be made.
- Works must be completed and the property occupied within 12 months of the grant being approved.
- Only one grant per dwelling is allowed and the property has to be re-occupied before the grant is paid.
- If the property is to be rented, the landlord must become a member of the Cheshire Landlord Accreditation Scheme on completion of the works.

**Please Note:** Owners must submit their application and have received written approval before starting the works and that grants and loans offered by the Council are subject to available funding.
