**Item 1:** All welcomed and apologies noted.

Meeting to be facilitated by Mandy and Clare until co-chairs are in place.

#### Item 2: Review TOR

Agreed it would be beneficial to have a visual (diagram) to illustrate TOR.

**Membership** – it was agreed:

that a stakeholder analysis would be useful.

It would be good to have a rep from Public Health and/or Exec. Director from health sector.

Inviting too many people would make the Board unmanageable and may be overtaken by professionals.

**Co-Chair** – A short description of what this involves would be useful and then all interested Inspirers to submit a short-written statement to Board members and then vote via email for their preferred choice. The Inspirer with majority vote would be elected for 12 months.

**Meeting format** – Agreed to meet monthly on last Tuesday of month and extend to 1.5 hours. It was commented that the Board should scrutinise and make recommendations and keep voting to a minimum. Agreed a code of conduct would be helpful; a working together model which reflects the principles of PTC.

## **Item 3: Communication**

Mandy updated the Board on plans to have a dedicated web presence for the Poverty emergency.

Agreed the best way to share information outside of meetings and keep in touch was via email.



Once the co-chair is in place, she would like to have regular catch up with them.

# **Item 4: Setting priorities**

Agreed the Board need to develop these collectively and are not at the stage to do that yet. However, there are a few things happening which the Board need to influence. It was agreed to form three small sub-groups:

**Transport review** – the Council is undertaking a whole review of transport across the Borough, including local bus contracts, community and rural transport, school transport, park and ride. A number of Community Inspirers volunteered to share their experience to help influence the review and inform evidence gathering.

**Data Collection and analysis** – it really important that we use a very data and evidence-based approach to shaping our 'recovery' within the council and working with other councils to drive change nationally if necessary. This sub-group will look at what data we may need, what's already available and any gaps.

Use of any remaining Council Tax COVID-19 hardship fund – CW and C received this fund to help support economically vulnerable households. Grants have been awarded to those eligible for Council Tax reduction and the PTAB task is to develop a policy for the use of unallocated funding to support work to tackle poverty locally, under the terms that the funds were received.

## **Item 5: Updates from Mandy**
